Regarding the change of the Trust name from '**N.S.Pinagapani Educational Society**' to '**Kaligi Ranganathan JJ Educational Trust**' for managing the '**KRM Public School**' the necessary resolution has been passed by the '**N.S.Pinagapani Educational**
